The Fund has environmental and/or social characteristics (within the meaning of Article 8 SFDR).

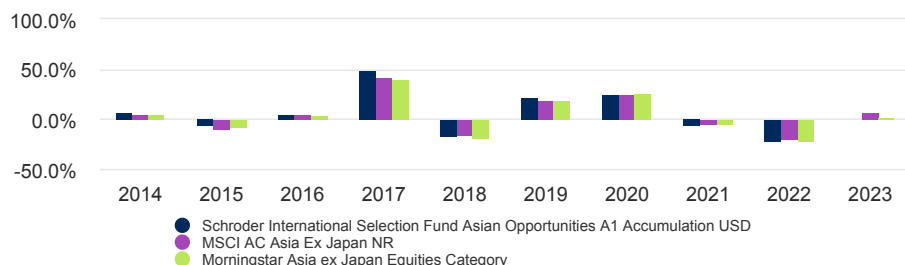

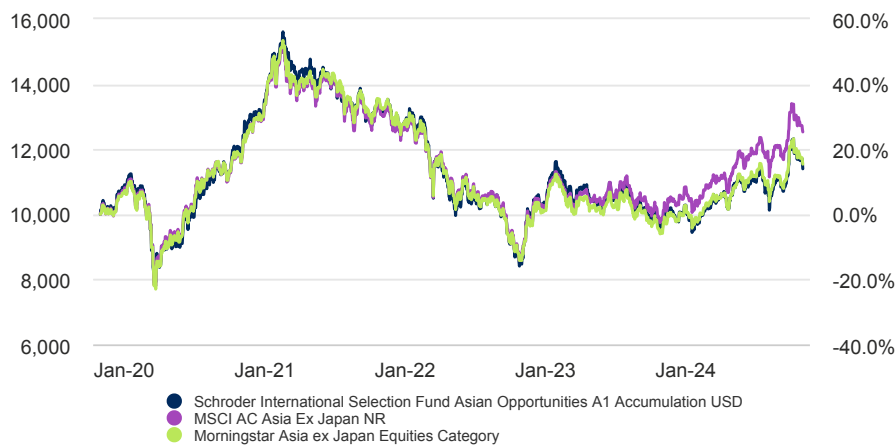

## Risk considerations

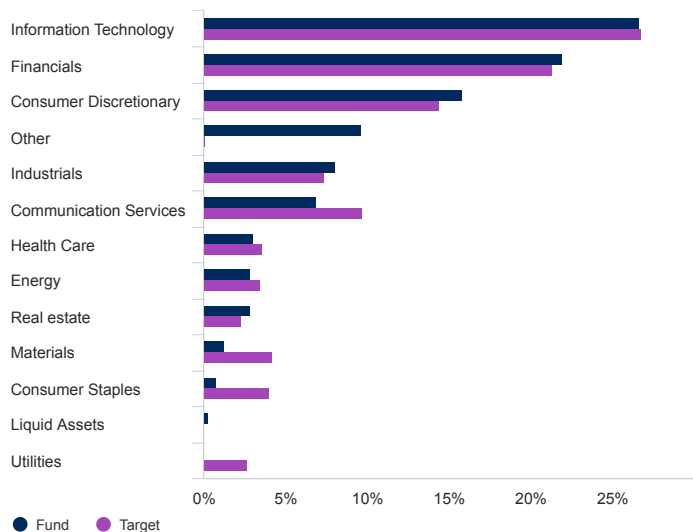

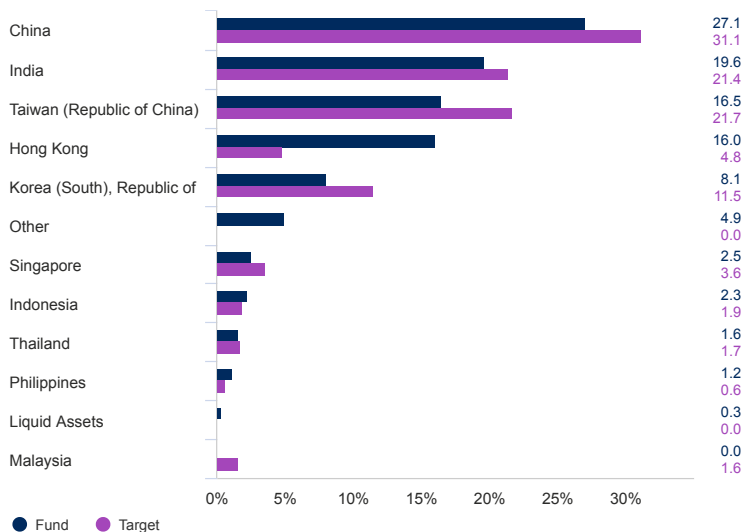

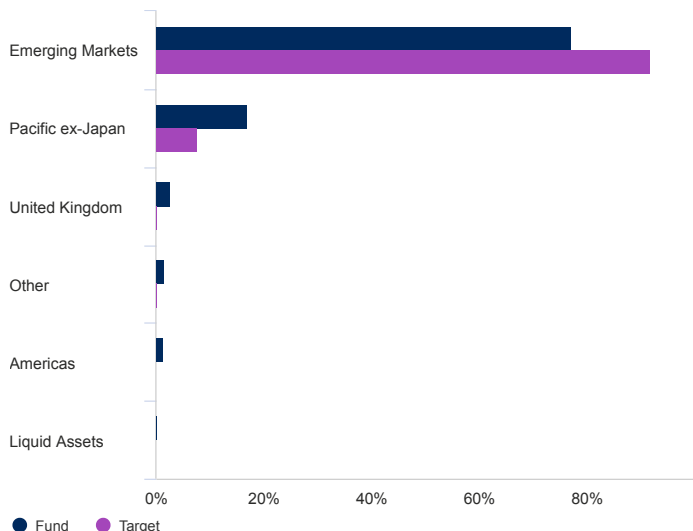
### Sector (%)
