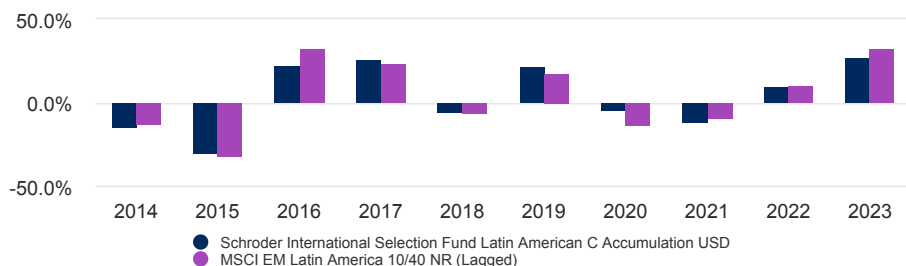

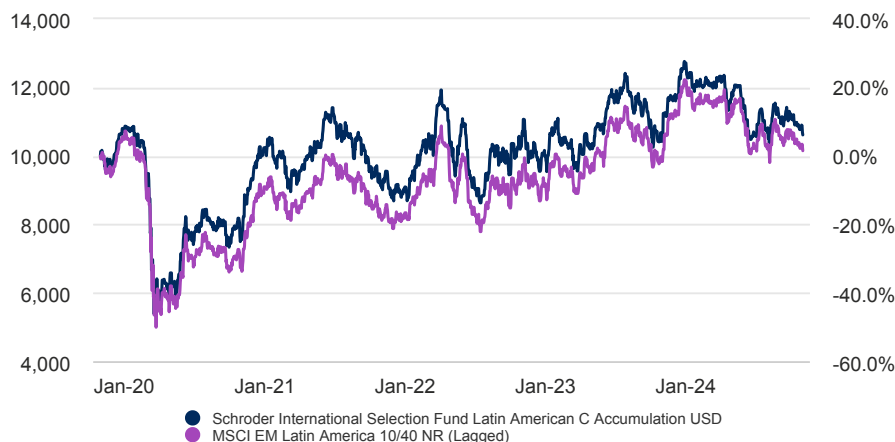

Risk considerations

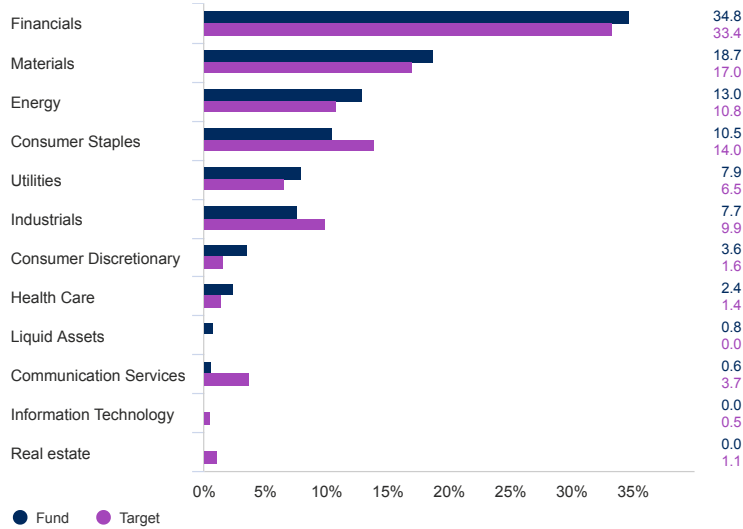

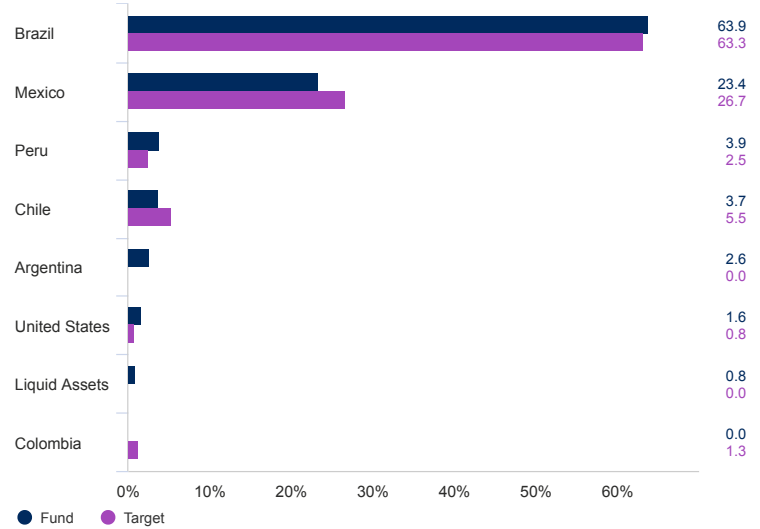
