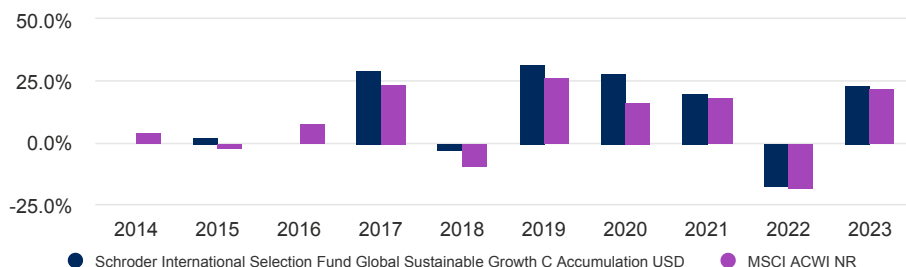

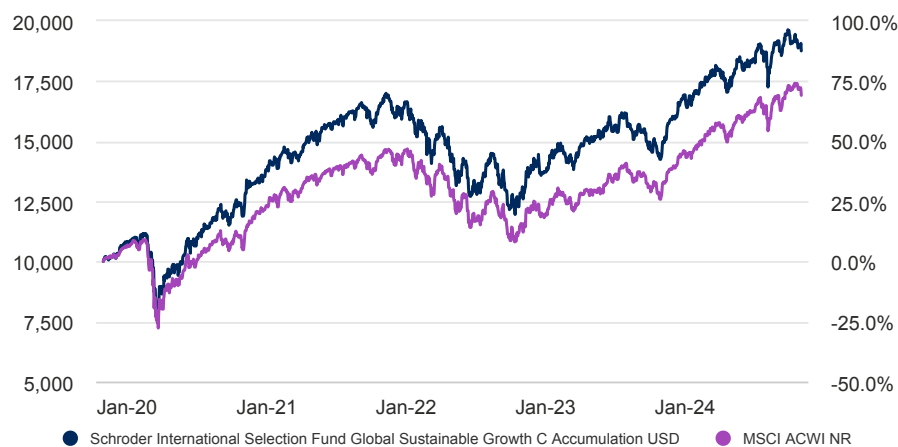

Risk considerations

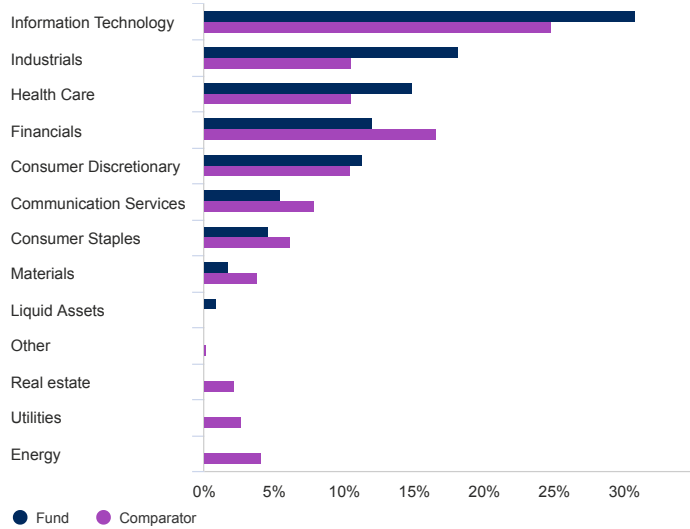

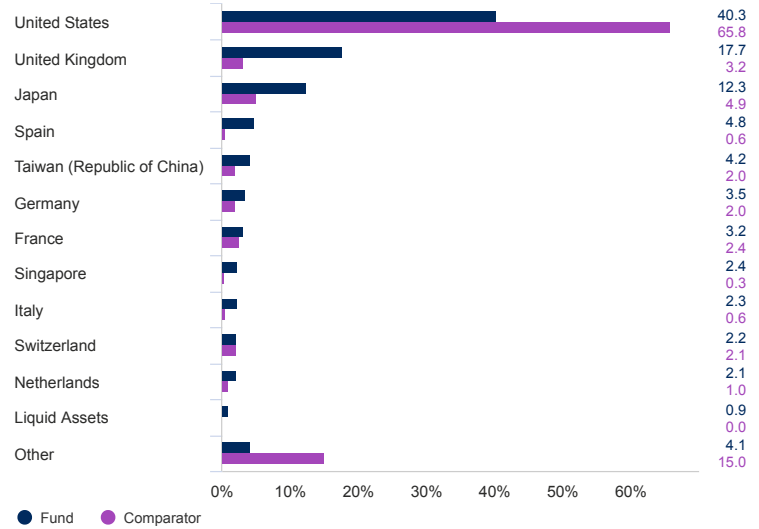

Asset allocation

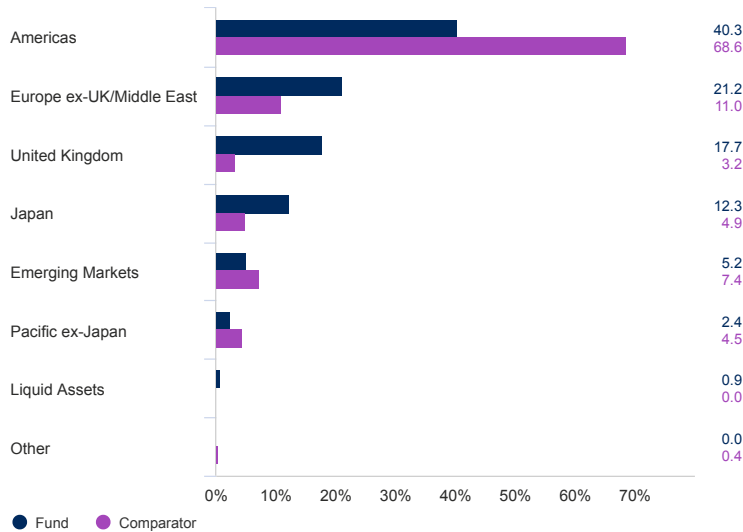
Sector (%)
