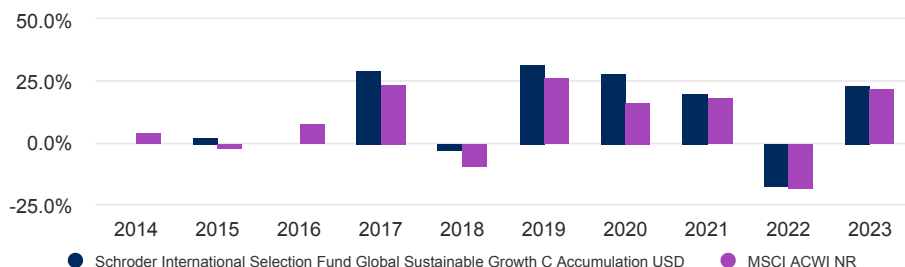

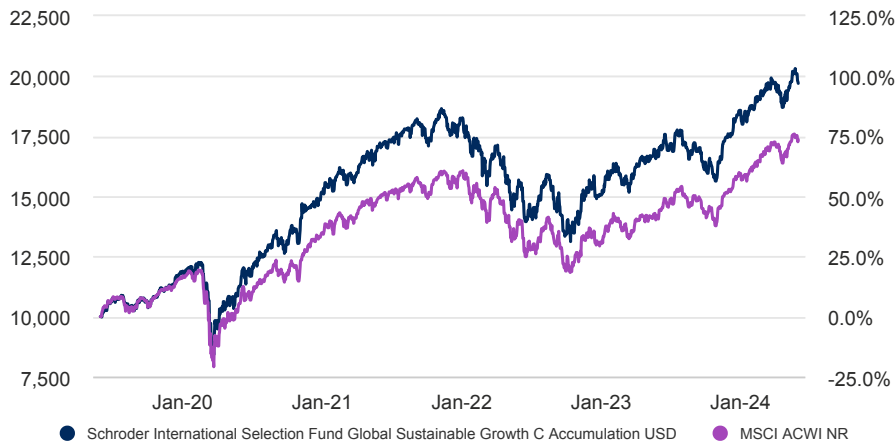

Risk considerations

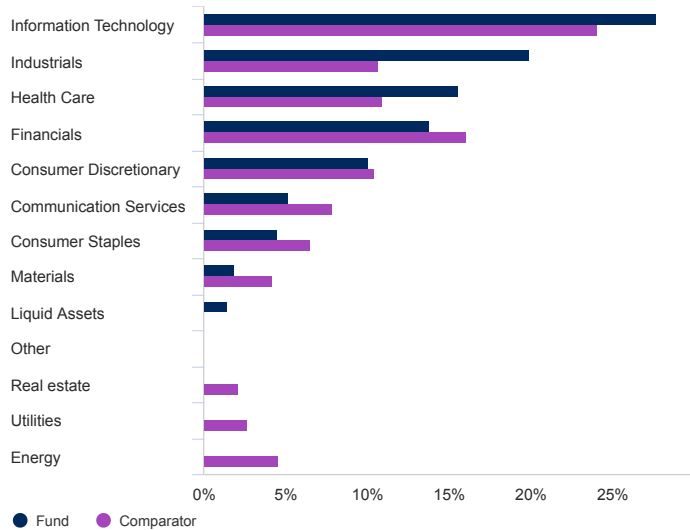

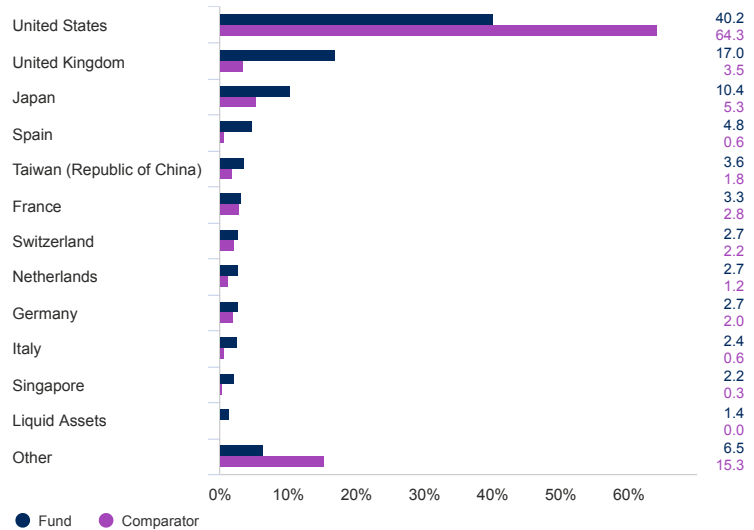

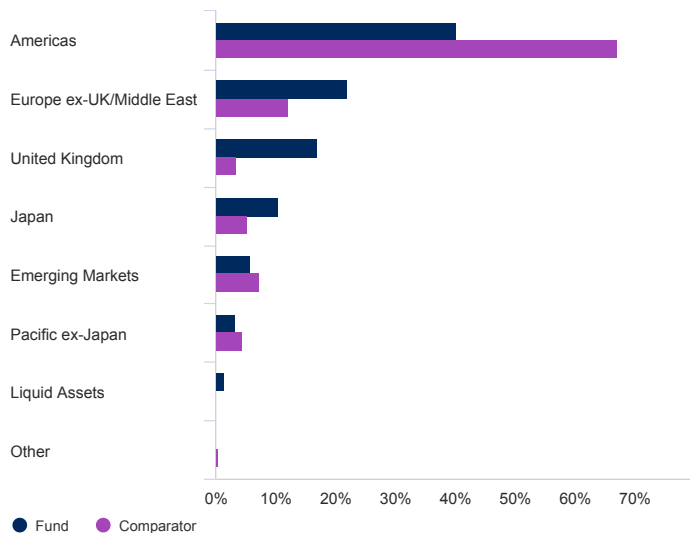
Sector (%)
