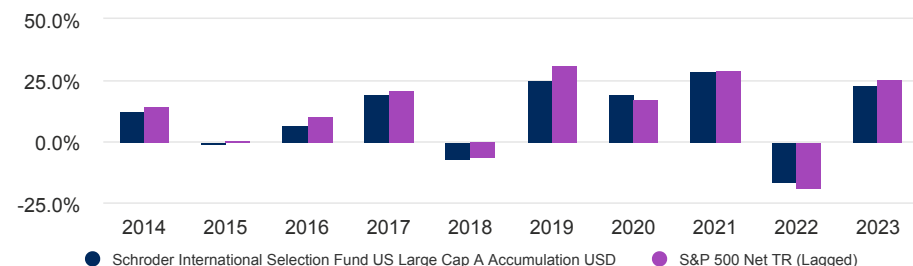

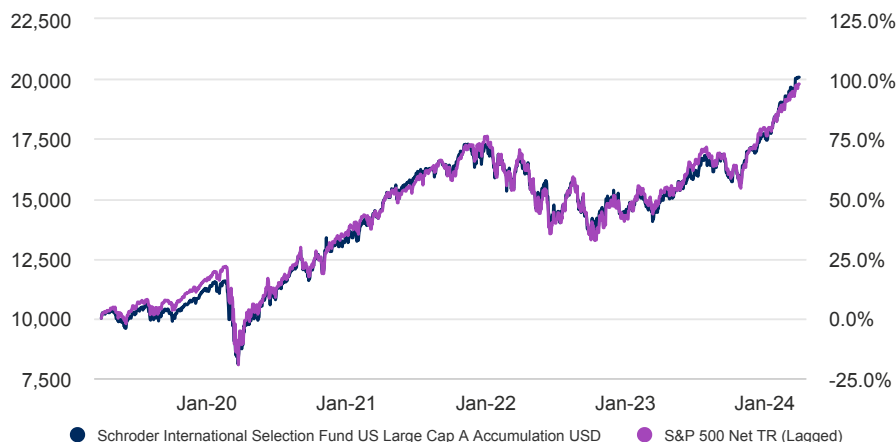

Risk considerations

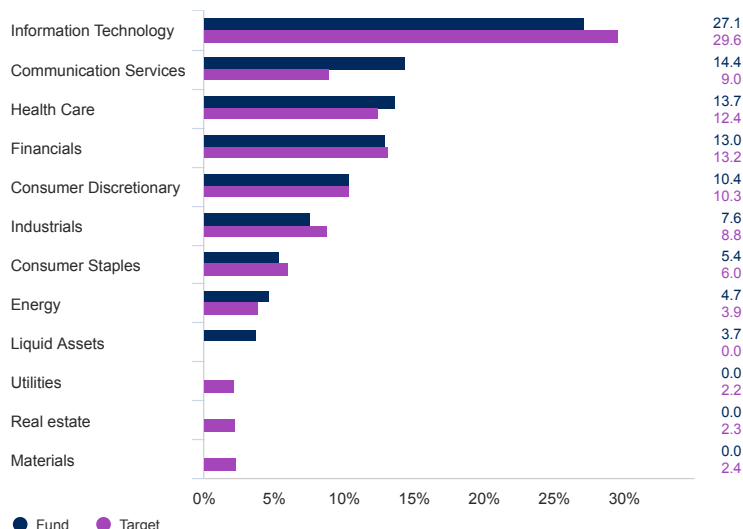

On 20.08.2001 Schroder ISF US Equity changed its name to Schroder ISF North American Equity. On 15.05.2006, this fund changed its name to Schroder ISF US Large Cap.
